NOTE:

1. Candidates preferably should come with all original documents along with their parent on **Monday, 14th September, 2026**. If original documents are submitted to other institute, then candidate should get the fee receipt, retention of document of that institute and one set of xerox copy of documents.
2. A vacant seat under minority category will be first offered to minority candidate only. If a minority candidate does not report, then that seat will be offered to a non – minority candidate.
3. Admissions will be given strictly on the basis of merit.
4. Candidates will be called one by one according to their merit number for counseling.

5. If the candidate is absent when his/her merit number and name is announced, the next candidate will be called immediately.
6. Counseling round will be conducted till all CAP Vacancy Minority Seats / Non-Minority Seats are filled. The candidates who have filled the pre-admission form for Minority / Non-Minority seats will be considered for respective type of seat.
7. Candidate can make payment through **Online mode** (Gpay/UPI/Net banking/Card etc) **OR** by Demand Draft in favour of **“K. J. Somaiya Institute of Technology”** payable at Mumbai amounting to **Rs 1,95,784/-**.
